

ORDINANCE NO. 04-2015

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GARNAVILLO, IOWA, BY AMENDING THE ZONING ORDINANCE R-2 DISTRICT PERMITTED PRINCIPAL USES AND STRUCTURES**

Be it Enacted by the City Council of the City of Garnavillo, Iowa:


**SECTION 1. SECTION MODIFIED.** Section 165.07, R-2 Mixed Residential Zoning District of the Ordinances of the City of Garnavillo, Iowa, is amended to add the following to the Permitted Principal Uses and Structures, thereof:

<b>PERMITTED PRINCIPAL USES AND STRUCTURES</b>	<b>MINIMUM REQUIRED OFF-STREET PARKING</b>
18. Emergency Services Buildings	1 space for every 1,000 square feet of floor area


**SECTION 2. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjunction shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 3. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
